

## PATHWAY AGREEMENT

### PROTEUS TECHNOLOGIES PTY LTD AND AUSTRALIAN LEARNING GROUP PTY LTD

#### 1. BACKGROUND

This Pathway Agreement is between Proteus Technologies Pty Ltd trading as Ikon Institute of Australia (Ikon) and the Australian Learning Group Pty Ltd (ALG) and allows students who successfully completed certain VET qualifications with ALG direct access into Ikon qualifications through Block Credit.

ALG operates colleges and schools in NSW, WA, VIC and QLD.

Ikon operates campuses in NSW, VIC, SA, WA, and QLD

Ikon extends to ALG students the opportunity to continue to further their study through this Pathway Agreement. The conditions of this Agreement are as follows.

This Agreement was proposed by the Director of Studies and Quality Assurance of ALG and the Executive Academic Manager of Ikon after thorough assessment for suitability for a Pathway Agreement between each institution's offered courses. This Agreement was approved by the Ikon Academic Board 13 July 2022.

#### 2. INTENT AND APPLICATION

The purpose of this Agreement is to:

- allow ALG's students who have completed their *CHC50113 Diploma of Early Childhood Education and Care* entry into Ikon's *Bachelor of Early Childhood Education* with advanced standing as detailed in Attachment 1.
- allow ALG's students who have completed their *CHC50121 Diploma of Early Childhood*

*Education and Care* entry into Ikon's *Bachelor of Early Childhood Education* with advanced standing as detailed in Attachment 2.

- allow ALG's students who have completed their *CHC51015 Diploma of Counselling*, *CHC53315 Diploma of Mental Health* and *CHC52015 Diploma of Community Services*, entry into IKON's *Bachelor of Counselling and Psychotherapy* or the *Bachelor of Arts Therapy* with advanced standing as detailed in Attachment 3.
- create an Admissions Pathway that results in no additional enrolment fees for ALG students to secure packaged Confirmation of Enrolments (CoEs)

All entry requirements are listed on the Ikon website and will need to be met by students applying for entry to a course at Ikon.

Spaces in Ikon courses are available to international and domestic students alike. Spaces are subject to availability and a valid Letter of Offer. Applications to study at any of Ikon's campuses can be submitted via: <https://ikon.edu.au/apply/>

### 3. MONITORING & REVIEW

This Agreement shall remain in effect until such time that either party wishes to review the Agreement, but will not extend past any expiry of Ikon's and ALG's registration with their respective course accrediting bodies.

A review and/or renewal of this Agreement shall be undertaken at the discretion of either party. In addition, this Agreement will be open to both parties for on-going evaluation. This Agreement can be terminated at any time by either party on the receipt of four (4) weeks' notice.

Any challenges that may arise during the lifetime of this Agreement can be addressed with the signing parties of each company.

### 4. COMMUNICATION

The nature and details of this Agreement must be communicated to all members of the respective courses in each institution and as well as:

- Marketing Officers at both institutions
- Enrolment/Admissions teams at both institutions


